- 1. Chief Secretary, Government of Arunachal Pradesh Chairman 2. Principal Chief Conservation of Forests and Principal Secretary (E&F) Ex-officio Member 3. Principal Chief Conservation of Forests (Wildlife and Biodiversity) Ex-officio Member Secretary/HoD, Department of Agriculture/Animal Husbandry Ex-officio Member 5. Secretary/HoD, Department of Horticulture Ex-officio Member Secretary/HoD, Department of Rural Development Ex-officio Member 7. Secretary/HoD, Department of Tourism Ex-officio Member 8. Secretary Law Ex-officio Member 9. HoD, Zoology, Rajiv Gandhi University, Rono Hills Non-Official Member 10. HoD, Forestry, NERIST, Nirjuli Non-Official Member Dean, College of Horticulture and Forestry, Pasighat Non-Official Member 12. Head of Office, Zoological Survey of India, Itanagar Non-Official Member 13. Head of Office, Botanical Survey of India, Itanagar Non-Official Member 14. Joint Director, Ayurveda Regional Research Institute, Itanagar Non-Official Member 15. CCF and Director, State Forest Research Institute Member Secretary
 - 2. The non-official Members of the Board shall hold the office for a term not exceeding three years at a time from the date of notification.
 - 3. Functions of the Arunachal Pradesh Biodiversity Board shall be to :-
 - (a) advise the State Government, subject to any guidelines issues by the Central Government, on matters relating to the conservation of biodiversity, sustainable use of its components and equitable sharing of the benefits arising out of the utilization of biological resources;
 - (b) regulate by granting of approvals or otherwise for commercial utilization or bio-survey and bio-utilization of any biological resources by Indians;
 - (c) perform such other functions as may be necessary to carry out the provisions of the Biological Diversity Act, 2002, or as prescribed by Rule 14 of the Arunachal Pradesh Biological Diversity Rules, 2011.
 - 4. The head quarter of the Board shall be at Itanagar, Arunachal Pradesh.
 - 5. Finance, Accounts and Audit of the Arunachal Pradesh Biodiversity Board shall be governed by the Clause 31 to 35 of the Biological Diversity Act, 2002.
